

POPIA CONSENT FORM

Personal Protection of Information Act 4 of 2013

According to the POPI Act, Global Wellness Enterprises is required to get your consent to collect, store, and manage the data that you provide to us. Consent to use personal information

Also, it means the dissemination using transmission, distribution, to make available in any other form, linking as well as blocking, erasing, or destruction.

Personal information may only be processed if it is adequate, relevant, and not excessive, given the purpose for which it is processed, and if processing occurs by the relevant provisions of the POPI Act. In addition, you hereby acknowledge that Global Wellness Enterprises collects and processes personal information about the proper functioning, management, and governance of the organization as guided by the relevant laws of the country.

In terms of section 11 of POPI, personal information may only be processed in the following circumstances:

- o If processing is necessary to carry out actions for the conclusion or performance of a contract to which the person/data subject is a party.
- o If processing complies with an obligation imposed by law on the organization.
- o If processing protects the legitimate interest of the person/data subject.

- o If processing is necessary for pursuing the legitimate interests of the organization.

Your rights in terms of this consent

- The right to correct your information When any of your information has changed or is incorrect, you may request that the information be updated. Global Wellness Enterprises will try to keep your information up to date.
- The right to know what information is being kept You will also have the right to know how we manage and share your information.
- The right to withdraw your consent You may at any given time withdraw your consent. This must be done in writing. A canceled or withdrawn consent will not affect any past or existing use of your information.
